RECOMMENDATION

Approval of the ranking and authorization for the Executive Director to execute contracts for the Tri-County Agricultural Area (TCAA) Water Management Partnership and Districtwide Agricultural Cost Share Programs' projects with a cumulative dollar total not to exceed \$706,922 for the TCAA Water Management Partnership projects and \$363,029 for the Districtwide Agricultural Cost Share projects and the related budget transfer.

TCAA BACKGROUND

The Tri-County Agricultural Area Water Management Partnership Cost Share Program was developed to assist farmers and growers with implementing projects that conserve water and result in nutrient loading reductions.

Funding for this cost share program is provided on a year to year basis by the Florida Department of Environmental Protection (FDEP), the Florida Department of Agriculture and Consumer Services (FDACS), and the St. Johns River Water Management District (SJRWMD). FDACS serves as the "gate keeper" for applications and the three partners select agricultural projects for cost share opportunities. A fourth partner, the Natural Resource and Conservation Service also provides cost share opportunities to the Tri-County Agricultural Area growers (via federal dollars). To date, 113 projects have received funding through this program. Projects are eligible for cost share funding for 75% of construction cost with an annual cap of \$250,000.

TCAA DISCUSSION

There are two solicitations for this program each year. Projects approved from the first solicitation in July 2019 were funded by FDEP and FDACS. Seven applications were received for the second solicitation in February of this year. Six of the projects were recommended for funding; one of which has already been funded by FDACS. The five remaining projects are being recommended for funding through SJRWMD and are listed below in rank order.

Upon approval of the TCAA Water Management Partnership Cost Share contracts, there will be approximately \$835,880 remaining in the budget. These remaining funds will not be awarded this fiscal year and it is requested that \$138,300 of these funds be transferred to the Districtwide Agricultural Cost Share Program to cover the projects recommended for funding below.

DISTRICTWIDE AGRICULTURAL COST SHARE BACKGROUND

Beginning in FY 2015, the Districtwide Agricultural Cost Share program was developed to assist farmers and growers with implementing projects that conserve water and result in nutrient loading reductions. Projects are ranked based on benefit to the District's core missions, resource benefits, cost effectiveness and timeline to completion. The cost share program provides up to 75% of the project costs, not to exceed \$250,000, for the engineering, design, construction and implementation costs of the project. Awardees are expected to cover project maintenance costs for the life of the project and, if applicable, must modify their consumptive use permits to reflect water savings produced by SJRWMD funds. To date, 93 projects have been approved for funding.

DISTRICTWIDE AGRICULTURAL COST SHARE DISCUSSION

The Governing Board previously approved twelve projects for funding on October 8, 2019 from the first solicitation for this program. A second solicitation was sent out in January of this year and ten applications were received and reviewed by the Project Selection Panel. One project was not ranked because it did not meet the intent of the program and one project ranked too low to be recommended for funding. The eight remaining projects are being recommended for funding and are listed below in rank order.
