

Environmental resource permits

Environmental Resource Permits (40C-4, F.A.C.)

- Individual and conceptual permits \$5,380
- Mitigation bank permits and conceptual approvals \$11,960
- Modification of individual or conceptual permits, total land area not increased \$1,410
- Modification of mitigation bank permits or conceptual approval permits, total area not increased \$1,410
- Modification of individual or conceptual permits with land area increase \$4,230
- Modification of mitigation bank permits or conceptual approval permits with land area increase \$4,230
- Verification of Exemption. \$100

Standard environmental resource permits (40C-40, F.A.C.)

- Systems that have a project area greater than or equal to 40 acres \$1,790
- Systems that have a project area of greater than 1 and less than 40 acres \$1,190
- Systems that have a project area of less than or equal to 1 acre \$590
- Applications qualifying under 40C-40.302(5), F.A.C., for modification of individual or conceptual environmental resource permits, or mitigation bank permits or conceptual approval permits, where the total land area is not increased \$1,100

Noticed general environmental resource permits (40C-400, F.A.C.)

- Noticed general permits set forth 40C-400.417 through 40C-400.500, F.A.C. \$250
- Variances associated with an environmental resource permit application \$550
- Formal determination for property less than or equal to 10 acres \$860
- Formal determination for property greater than 10 and \leq 40 acres \$1,180
- Formal determination for property greater than 40 and \leq 120 acres \$2,370
- Formal determination for property greater than 120 acres \$2,370
 - Plus \$310 for each additional 100 acres or portion thereof
- For properties with an existing formal determination that qualify for a lower fee in accordance with Rule 40C-1.1006(7), F.A.C. \$350 management and storage of surface water permits (40C-4 and 40C-40, F.A.C.)
- Applications submitted pursuant to the grandfathering provisions
- Individual and conceptual permits \$3,530
- General permits \$980

Permit applications and formal determinations which require wetland delineations pursuant to section 373.421(7), FS, will be charged a supplemental application fee of seven hundred dollars (\$700) in addition to the application fees above.

Additional Fees will apply to Environmental Resource Permits that include Sovereign Submerged Lands applications:

- SSL Lease application - private residential single-family dock or pier \$240.00
- SSL Lease application - all other facilities \$606.00
- All applications for Private or Public Easement \$606.00

Environmental resource stormwater permits (40C-42, F.A.C.)

- Stormwater facility for a project with a total land area \leq 1 acre \$280

- Stormwater facility for a project with a total land area >1 acre \$490
- Applications submitted pursuant to the grandfathering provisions
 - Stormwater facility for a project with a total land area <= 1 acre \$220
 - Stormwater facility for a project with a total land area >1 acre \$440
- Verification of Exemption. \$100

Artificial recharge injection well permits (40C-5, F.A.C.)

- Artificial recharge injection well permits \$5,000

Wetland resource management (dredge and fill) permits (62-4 and 62-312, F.A.C.)

- Dredge and fill permits issued pursuant to the grandfathering provisions
- General permits \$150
- Short-form permits involving the construction of new docking or boardwalk facilities providing 0–2 new boat slips \$460
- Short-form permits involving the construction of new docking or boardwalk facilities providing 3–9 new boat slips \$760
- Short-form permits involving dredging and filling activities that affect 10 acres or less of jurisdictional area up to and including five years duration \$760
- Short-form permits involving dredging and filling activities that affect 10 acres or less of jurisdictional area from six years up to and including 10 years duration \$4,600

Standard form permits:

Environmental resource agricultural system permits (40C-44, F.A.C.)

- Standard general permits for agricultural operations less than 40 acres \$420
- Standard general permits for agricultural operations greater than 40 acres \$1050

- Individual permits \$2,820
- Verification of Exemption. \$100

Environmental resource agricultural system permits issued pursuant to the grandfathering provisions

- General permits for agricultural operations less than 40 acres \$470
- General permits for agricultural operations greater than 40 acres \$940
- Individual permits \$2,840

Environmental Resource Permit requests for modification by letter (40C-1, F.A.C.)

- Requests for modification by letter of individual or conceptual environmental resource permits, or mitigation bank permits or conceptual approval permits \$270
- Requests for modification by letter of Chapter 40C-40, F.A.C., standard environmental resource permits, where the total land area of a project is not increased \$160
- Requests for modification by letter of Chapter 40C-42, F.A.C., Permits \$110
